Summary Description

The Clifford Capital Partners Fund's objective is long-term capital appreciation. The Fund is invested in stocks across the market cap spectrum (*all cap*).

Opportunistically Seeking Value. We invest in stocks where we view expectations as too low, leading to a purchase price at a meaningful discount to intrinsic value.

Independent, Focused Research. Our proprietary research is condensed into the 3-4 factors (Key Thesis Points[™]) we deem most critical for each stock's success.

Long-term Focus. Every investment thesis reflects our long-term views (3-5 years).

Repeatable Process. We believe that individual stocks are often mispriced because short-term centric investor behaviors lead to ample opportunities.

Contrarian. We believe we must think and act differently to produce differentiated results. We strive to move against the crowd at investment entry and exit points.


Meaningful Position Sizes. The Fund normally holds between 25 and 35 stocks, which we believe allows each stock to have a meaningful impact on the Fund's results.

The overall portfolio construction is guided by a dynamic mix of two types of stocks:

Core Value stocks – investments in companies we believe are high-quality firms earning high returns on capital. Core Value stocks are 50-75% of the Fund.

Deep Value stocks – opportunistic investments in companies we believe are deeply undervalued. Deep Value stocks and cash are 25-50% of the Fund.





Alpha measures the difference between the fund's actual returns and its expected performance given its level of risk. Beta is a measure of the fund's sensitivity to a benchmark. Down Capture Ratio measures the portion of bear market movements that the fund captured. Ideally, the down capture will be less than 100%. Median is the data's midpoint value. Market Cap is the aggregate value of all of a company's outstanding equity securities. Weighted Average is the average of values weighted to the data set's composition. Weighted Harmonic Average is a calculation of weighted average commonly used for rate or ratios. Price-to-Book Ratio (P/B Ratio) is the ratio of a stock's price to its book value per share. Price-to-Earnings Ratio (P/E Ratio) is the ratio of the current price of a stock to the latest 12 month's EPS; P/E ex-negatives ratio is an exposureweighted average of the P/E ratios of the securities held in the Fund, excluding companies with negative earnings. Sharpe Ratio calculates the amount of fund return in excess of the risk-free rate per unit of risk (standard deviation) taken by the fund. Sortino Ratio calculates the amount of fund return received in excess of the risk-free interest rate per unit of "downside" risk (standard deviation of negative returns) taken by the fund. Standard Deviation is a statistical measure of the volatility of the fund's returns. Up Capture Ratio measures the portion of bull market movements that the fund captured. Ideally, the up capture will be greater than 100%.

1 For each fund with at least a 3-year history, Morningstar calculates a Morningstar Rating based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly performance (including the effects of sales charges, loads, and redemption fees), placing more emphasis on downward variations and rewarding consistent performance. The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star. (Each share class is counted as a fraction of one fund within this scale and is rated separately, which may cause slight variations in the distribution percentages.) The Overall Morningstar Rating for a fund is derived from a weighted average of the performance figures associated with its 3-, 5- and 10-year (if applicable) Morningstar Rating metrics. The Morningstar Rating is for the Institutional share class only; other classes may have different performance characteristics. Across U.S.-domiciled Mid-Cap Value funds, the Partners Fund received 2 stars among 383 funds and 3 stars among 363 funds for the 3and 5-year periods, respectively.

Information about Risk

Risks of Investing in Equity Securities. Overall stock market risks may affect the value of the Fund. Factors such as domestic economic growth and market conditions, interest rate levels, and political events affect the securities markets. When the value of the Fund's investments goes down, your investment in the Fund decreases in value and you could lose money. Risks of Small-Cap and Mid-Cap Securities. Investing in the securities of small-cap and mid-cap companies generally involves substantially greater risk than investing in larger, more established companies. Risks of Large-Cap Securities. Prices of securities of larger companies tend to be less volatile than companies with smaller market capitalizations. In exchange for this potentially lower risk, the Fund's value may not rise as much as the value of funds that emphasize companies with smaller capitalizations. Focused Investment Risk. The Fund is a focused fund and generally holds stocks of between only 25 and 35 companies. Focused funds may invest a larger portion of their assets in the securities of a single issuer compared to a more diversified fund. Focusing investments in a small number of companies may subject the Fund to greater share price volatility and therefore a greater risk of loss because a single security's increase or decrease in value may have a greater impact on the Fund's value and total return. Sector Risk. The Fund may emphasize investment in one or more particular business sectors at times, which may cause the value of its share price to be more susceptible to the financial, market, or economic events affecting issuers and industries within those sectors than a fund that does not emphasize investment in particular sectors. Management Style Risk. Because the Fund invests primarily in value stocks (stocks that the Adviser believes are undervalued), the Fund's performance may at times be better or worse than the performance of stock funds that focus on other types of stock strategies (e.g., growth stocks), or that have a broader investment style.
